PROPOSED NORTH FORK ROAD PAVING PROJECT UNDERFUNDED

It appears that the money allocated by Congress to pave 10 miles of the North Fork Road south of Camas Creek is only two-thirds of the amount required to do the job. According to an article in the May 2, 2000 *Daily Inter Lake*, "The Federal Highway Administration estimates the project is about \$1.2 million short of what's needed."

The article goes on to say that the \$2.4 million approved last September was probably not quite sufficient for the construction costs and even that amount was subsequently cut by 13% as part of an effort to meet overall federal spending caps for highway funding. Factor in environmental review (\$700,000) and design and engineering expenses (\$80,000), and the shortfall is almost \$1.2 million.

At this point, it is probably too late for the county to obtain enough additional money to fund the project. There is apparently some likelihood that the funds will be transferred to another project — the article mentioned Big Mountain Road as one possibility.

ROADLESS INITIATIVE HEARINGS COME TO KALISPELL

The U.S. Forest Service (USFS) will be holding public hearings on the Roadless Initiative in Kalispell on June 26 and 27. Originally scheduled as a series shorter meetings at the Outlaw Inn, the sessions have been expanded and moved to Kalispell High School where there will be room to accommodate more participants.

Here is the announcement placed by the USFS in the June 13 *Daily Inter Lake* (emphasis in italics added by the editor):

The following meetings to collect comments on the proposal and environmental impact statement for managing roadless lands on national forests and grasslands are scheduled for the Flathead National Forest:

Monday, June 26, 5:00 to 9:00 p.m., Kalispell High School Auditorium, 644 4th Ave. West, Kalispell

(There will a 10 minute break each hour)

Tuesday, June 27, 5:00 to 9:00 p.m., Kalispell High School Auditorium, 644 4th Ave. West, Kalispell

(There will a 10 minute break each hour)

This is a new location with expanded hours to accommodate more participants.

At these meetings individuals can make oral comments and have them recorded by a court recorder. The comments will then be sent directly to the team writing the Roadless Area Conservation EIS. *Those who wish to make oral arguments can sign up any time after 4:30 p.m. the day of the meetings*, oral comments will be recorded in the order of sign up. Individual can only make oral arguments once over the two days to allow the maximum number of people to comment. Each commenter may speak for up to 3 minutes.

The extended hours will allow some flexibility for individuals to come and go, rather than spend the entire evening. *Written comments can be submitted any time before July 17. All comments whether by mail, e-mail, orally, or FAX are treated equally* so those interested can chose the most convenient method. Individuals can comment in writing as often as they wish.

And here is an excerpt from *Wild Flathead*, the newsletter of the Flathead Chapter of the Montana Wilderness Association, May, 2000, summarizing the Roadless Initiative:

The Roadless Initiative does not create one new acre of wilderness! However, it does provide the best opportunity to secure a policy protecting the remaining roadless lands.

If adopted, part one would immediately restrict certain activities such as road construction in roadless areas identified in RARE II and existing forest plan inventories.

Part two would establish a national direction for managing roadless areas and would help determine if similar protection should be extended to uninventoried roadless areas. Part two would be implemented at the forest plan level through the plan amendment and NEPA process.

This national direction would guide land managers in determining which activities are consistent with protecting the important ecological and social values associated with inventoried roadless acres. It would also guide land managers in determining which activities are appropriate in uninventoried roadless areas.

FLATHEAD NATIONAL FOREST WILL SEE FEWER SERVICES

This summer visitors to Flathead National Forest will see fewer services. The U.S. Forest Service (USFS) was given only a \$12.4 million budget, down \$2.2 million from last year. Alan Rowley, USFS Public Affairs Specialist from Kalispell, said there are two main reasons for the cuts. First, money was needed for the increased administration and personnel in the USFS National Office in Washington. D.C. Second, funds were required for national programs such as the Roadless Initiative and Vice President Al Gore's Clean Water Action Plan. Rowley said that the Flathead National Forest budget has consistently dropped over the last 10 years by about \$1 million annually.

This year's budget cuts will impact seasonal jobs, trail projects and many other services. There will be only 100 seasonal jobs, down 118 from last year. Rowley also stated that only 500-600 miles of the 1100 miles of trails would be maintained, only 50 miles of road will be graded (650 miles were graded last year) and that there will be no pre-commercial thinning in the forest.

There will be only 21 "attack" fire fighters (there were 54 last year). If the fire fighters need additional assistance this summer, they will request help locally then seek assistance from nearby organizations such as Glacier National Park.

Instead of last year's eight personnel, there will be only a four-person crew to spray for noxious weeds. Spraying will be confined to popular scenic sites, trailheads and river access points. Some examples are Big Creek, Ford and Glacier Rim.

The budget cuts will not affect periodic maintenance on the Hungry Horse campsites or forest law enforcement.

This summer, various organizations such as NFPA and the Backcountry Horsemen are volunteering to help clear some of the forest trails. Rowley said that the Forest Service would identify later this summer which trails are to be cleared. STATE OF THE ECOSYSTEM REPORT DUE OFF THE PRESS SOON

Emphasis has been placed on the human and natural history of the watershed from the headwaters in British Columbia to it's joining with the Middle Fork at Blankenship. Research and written contributions to the report have come from a diverse group of citizens, resource professionals and scientists.

The NFPA helped move this document towards completion with a generous contribution at a critical stage.

Final production, printing and distribution are expected in July. Ben Long, a free-lance writer and columnist to the *Daily Interlake*, has taken on the job of the final edit. The report will be available through NFPA.

FBC PRESSES **IJC** ON NORTH FORK ISSUES

In a letter to the Chairman of the United States Section of the International Joint Commission, the FBC has asked the IJC to consider the formation of an international watershed board for the North Fork of the Flathead River. The Commission said the group would be a "responsible, pro-active way of improving broad-based opportunities by interests in both nations [Canada and the U.S.] for monitoring and addressing a wide range of issues that relate to the future of this shared resource." The IJC arbitrates water-related issues between the U.S. and Canada.

British Columbia, meanwhile, has expressed interest in working with Montana to establish a border-wide agreement to cover a wide range of shared concerns, including water quality.

500 ACRES OF OLD GROWTH SLATED FOR LOGGING IN NORTH FORK!

State Lands is at it again. Selling off and cutting down old growth that they agreed not to cut. At issue is the Coal Creek State Forest's Unit 5 sale. Five hundred acres of the genuine old growth article. State foresters agreed to an old growth cutting moratorium for this until they revised their old growth policy. However, agency personnel are under pressure to "get the cut out" and Unit 5 is critical if they are to meet their election time target.

The sale has nothing to do with forestry. Everything to do with politics and administrative target.

MWA plans to be heard in Helena on June 19 at the State Land Board Hearing where the fate of the forest will be decided. Three gubernatorial candidates are on that board, O'Keefe, Mazurek, and Cooney. So is the present governor.
